Those who are pushing this have an allegiance, a honourable allegiance to IAAF rules. Some would like to see OCR in the Olympics. This cannot happen unless OCR Joins Athletics UK and Athletics Worldwide under the permission of I.A.A.F.

To do this each Honourable Race Organiser must obtain an Athletics Permit and pay a tariff to the greatness of Athletic Clubs. This system is contained in the constitution and objectives of HORBA.

HORBA has commenced negotiations with the authorities of Athletics UK and Sport UK to become a part of the affiliated bodies.

You as a member will have a free vote on how that tariff will be paid.

These are the known choices:-

- 1) Pay £2 per runner for Athletic Permit which you as organiser will be indebted to collect.
- 2) Join a central online registration scheme where 5% of your income is taken at source and passed to UK Athletics.
- 3) Alternatively, this 5% is taken as extra tariff over and above your entry fee.
- 4) Sponsorship deal where every piece of kit has a sponsors emblem.
- 5) Agree to further involvement with the Governing Body with central kit sales.

- ALL Participants on payment of fees need to be assured that if the event fails they will be assured a transfer to another member event.
- ❖ ALL such Members events agree that if by one month before the event they know that failure is imminent – they will contact the OCR Organisation, ask for help or transfer ORunners to another Member.

#### FAIL SAFE


- > IF a participant has signed up to a O.C.R.D.UK member event.
- > IF that event should collapse into liquidation the participant will be able to enter another member event at a minimal fee to costs (£10)? Open to debate.
- > IF an event declares a need to cancel for any reason, that Event Organiser will negotiate transfer of participant with a neighbour event.

## Creation of the Movement

During the past few years Mr Mouse has spent every sleep deprived moment on a mission, inspired by the spirit of Chris Brasher. Chris was inspired by Fred Lebow New York Marathon.

In 1980 the late great Fred Lebow, creator of New York Road Runners and New York Marathon did gracefully allow all to learn from him and freely gave the sport of Joe Jogger mixing with elite. The Family of Man was born of Inspiration by Chris Brasher who then launched AIMS Association of International Marathons

The Sport Council asked Chris Brasher and Billy Wilson to create a Registration Scheme. After 3 years work Chris approached the Palace for the Princes Trust to help create Inner City Aid. The democratic British association thought differently, Chris said let's talk refreshingly about the countryside. Tough Guy™ was created in 1986. Chris said dont measure the distance, John said add some Quirky Names. Thus these past few years Billy Wilson morphed to Mr Mouse has written many words of Mission Impossible. You should praise him, he should praise you. You all need to Bow to GOD. Look forward to see you visiting here I do not travel far? When are you arriving?

## "The Second Mouse gets the Cheese"

The First Mouse to create a book on Adventure Obstacle Running was Paul Pickering see attached. After 1 year of monthly publications he was defeated lost money, I pleaded with him to stay that I would fund the production. Paul was not convinced he went to Sandhurst for Military Commission.

My first love is horse and kids off the street. Horse helped rescue my daughter to a better life. So I set out to, Horse Help other kids, with a Sanctuary.

To fund the Sanctuary I organised the first dirty runs – Jolly Holly Jog December 26<sup>th</sup> 1978 followed by a farmyard muck and bale run in January 1979, a Muddy Hill Climb, 10 miler on Feb Valentine's Day 14<sup>th</sup> 1979. Half path and field Marathon May 1<sup>st</sup> 1979, then the marathon boom arrived big time, athletics only serious runners.

I dressed as Panto Horse 1981, first London Marathon attracting the Media to the fact that Joe Jogger could run equality also the fact that we could attract kids with enormous talent wasted on their destination to street life. I spent 5 years with Chris Brasher sitting top table Amateur Athletics Association but they dug their heels in to sway my revolutionary aspect back to the traditional, excluding fun runs from being worth of Athletic Permits.

#### **FUN RUNS**

No timings needed, no set measured distance, no prizes, no inducements. Thus I created Tough Guy® as the Fun Run that squashed the word Fun into Fear Fun, Terror Miles, Brutal Wooded Hillsides, Farm Muck, Cattle Electric Fences, Tree Climbing aid Swinging Ropes. Plus numbering with a marker pen because paper numbers were destroyed.

My Guards Special Forces Training came into building high risk with hidden safety devices.

So by 1989, I declared "The Safest Most Dangerous Fear & Plenty 4 hours of life, built by Tough Guy® Special Forces".

The challenge was that I would build a new Obstacle every event to purposely stop the competitors to admit defeat by the mighty Tough Guy®.

I also built a story into it with a new Logo, Fierce Picture and Name every event. I decided that these young enthusiasts for fear adventure pain and punishment were similarly enthusiast to us troops going off to war. Thus by naming obstacles like the Battle of the Somm, Gallipoli, fierly Holes of Ypres, the deadly tunnels beneath enemy lines at Verdun. I could really say to them all. This is what your Grandfathers suffered for you.



It was a pleasure to meet you and Mrs Wilson last week.

As promised, I have set down a brief summary of the points discussed at the meeting and the actions

# TOUGH GUY in the USA

Michael Epstein's registration for the mark TOUGH GUY in the USA is proceeding forward to registration in the USA. This means that he has acquired the exclusive rights to use the TOUGH GUY mark on sporting competitions in the USA. This would obviously prevent you or a US film company using your mark in the USA.

You remember Mr Epstein visiting your event in the past and taking notes etc. His mere knowledge of your event would not be enough to challenge his registration. We would need to show that your TOUGH GUY race had a trading reputation in the USA and provide evidence that Mr Epstein was improperly appropriating that reputation. Epstein would always have the argument that he simply chose the name TOUGH GUY to describe a physically arduous race. Our conclusion was that due to these difficulties and the cost of any litigation in the USA, it simply is not worth pursuing this issue at present.

# TOUGH GUY in the European Community

Given the problems in the USA, we agreed to act now to file a trade mark application to protect your TOUGH GUY word mark via the Community Trade Mark system. Once granted such a registration would give exclusive rights in the TOUGH GUY mark in twenty European countries, including the

In addition to the organisation of sporting events covered by class 41, we also agreed to use the other two classes included within the standard application fee for the CTM to cover video and DVD recordings in class 9 and photographs and printed matter in class 16.

## TOUGH GUY in the UK

We also agreed to proceed with filing an application to protect your TOUGH GUY word mark in the UK. You already have a registration of the TOUGH GUY logo in the UK, but this disclaims the words themselves and therefore currently provides inadequate protection.

Due to the use that you have been making of the TOUGH GUY mark in the UK over the years, we should now be able to obtain a registration for the word mark alone, in relation to organising of adventure races on the basis of evidence of use.

# of Original Failed (P)Suicide Bommer

hen I was 19 years old, a Trained S oldier and Regimental Barber to Grenadier Guards No. 1 Battalion. I listened to; confessions, personal problems and gratifications of Officers, Sgt Majors and a host of other Ranks.

When I hit Civvy Street, it was so tame, The Recall to Arms and The Flag was undeniably superstrong.


But I had a Mother being battered by a Drunkard Husband and as the eldest I had a job to do at home.
